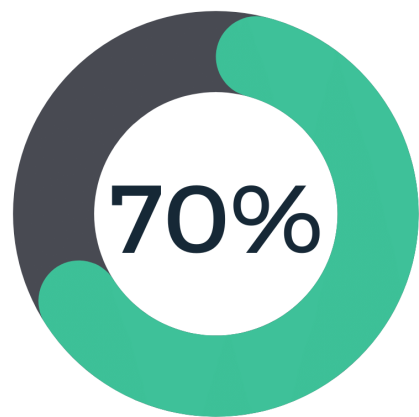
Search by Patent Number

Patent number search allows users to simply enter the patent number of their underlying case, and Juristat will recommend a list of experts based on subject matter expertise, PTAB experience, and cost. Further, it includes a link to a text-searchable version of the expert's most recent CV and declaration.

Search by Keyword/Phrase

Sometimes patent number searching can deliver limited results, especially in technology areas with few IPRs. This is where text searching shines. Say you are looking for an expert in a cut-

ting-edge field like vertical take-off and landing. Juristat gives you the ability to simply search every single CV and declaration ever filed at the PTAB for these keywords, allowing you to uncover lesser-known experts who aren't even on your recruiter's radar.

Search by Name

Finally, if you've narrowed down your expert to just a few candidates you can type their name into the Name Search field and find all of their experience at the PTAB, whom they worked for, and when. This is great for figuring out who in your professional network may be able to provide an off-the-record reference about the expert. Further, this is a useful place to see whether the expert is repeatedly rehired by the same firms and assignees.

It's worth noting that many clients also use Name Search for opposition research. Once the opposition expert is revealed, you can do recon on his or her past opinions and cases, something that recruiters never provide.

Patent Number

Subject Matter Experience

To determine an expert's subject matter expertise, Juristat measures three variables:

1. CPC Classification

We take the CPC class, subclass, group, and subgroup of the underlying patent entered by the user and score experts based on their prior experience in these areas. Experience in the same subgroup is scored higher than the same group, which is scored higher than the same subclass, and so on.

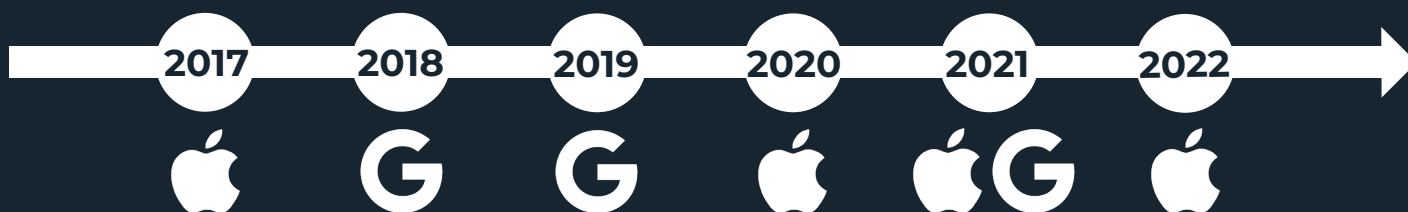
2. Keyword Analysis

Our AI analyzes the keywords and phrases of all the claims/specs that each expert has opined in and compares them to keywords and phrases in the underlying patent to find and rank similarities.

3. Patent Family

Patent family experience is denoted by a plus (+) sign next to the expert's name indicating the expert has opined in a case that is in the same patent family as the underlying patent.
